OATH OF ADMISSION

I, _____, having submitted an application to practice before the Snoqualmie Tribal Court, solemnly swear or affirm the following:

1. I am an attorney duly licensed to practice law in the State of _____ and that I am in good standing with said state bar;
2. I have read the Snoqualmie Indian Tribe's Constitution and laws and am familiar with their contents;
3. I have read and am familiar with the Constitution of the Snoqualmie Tribe, Tribal Codes and Court rules which have been adopted consistent with the federal Indian Law principles of tribal sovereignty and self-determination, and which are relevant to the cases I will be appearing before the Tribal Court;
4. I will abide by the rules established by the Snoqualmie Tribal Council and the Snoqualmie Tribal Court;
5. I will at all times maintain the respect due to the Tribal Court and its officers;
6. I will not counsel or speak for any suit or proceeding which shall appear to me to be unjust, or any defense except such as I believe to be honestly debatable under the laws of the Snoqualmie Indian Tribe unless it be in defense of a person charged with a criminal offense;
7. I employ such means only as are consistent with the truth and honor and will never seek to mislead a judge or jury by any false statements;
8. I will abstain from all offensive conduct in the Tribal Court; and
9. I have paid to the Tribal Court an admission fee of \$100.00.
