_____ I understand that the Tribe will own the exclusive rights to the Materials. I hereby waive any and all rights I may have to any claims for royalties, payment, or other compensation in connection with use by the Tribe of the Materials.

_____ I hereby release, discharge and hold harmless the Tribe from all claims, damages, and liabilities of any kind arising out of or in connection with (i) the use of the photos in connection with the Materials, including, without limitation, claims based upon invasion of privacy, defamation, copyright or trademark violation, right of publicity, or false light and (ii) any blurring, distortion, alteration, optical illusion, editing, or use in composite form, in whole or in part, whether intentional or otherwise, that may occur or be produced in connection with the Materials.
