PURPOSE: The Snoqualmie Indian Early Education Benefit was developed to give Tribal children better access to educational opportunities by assisting Tribal families with early education (infant to Pre-K onsite programs and homeschooling) related expenses. This benefit is intended to be the payer of last resort for tuition, fees, and deposits after all grant options have been exhausted .

Eligibility: All student applicants must be an enrolled Snoqualmie minor child.

Available Benefit Amount: An eligible child may receive up to \$15,000 to cover tuition, fees, and other supplemental educational support expenses as recommended by their program. An eligible student can allocate up to \$7500 of their total benefit per academic year towards homeschooling expenses. The Academic Year, regardless of school or program, is defined as July 1-June 30. Funding for this program is subject to availability of tribal resources and budget approval by Snoqualmie Tribal Council. All requests must be dated within the current Academic Year to be considered for reimbursement or payment. Upon receiving a complete application, requests may be processed within 14 business days.

Eligible Expenses:

- School tuition, summer school, tutoring or other supplemental educational support expenses: tuition, registration fees, supplies required by the program.
- School affiliated fees and expenses: school photos, class fees, field trip fees, uniform fees, other required fees
- Technology and software costs, including Microsoft Office or similar, other educational software, and technology equipment as required or recommended by a teacher, tutor, homeschool need, or school program. Purchase of same/similar technology equipment is only allowed every 3 years. Laptops, desktops, ipads, tablets are all defined for the purposes of this program as similar items.

- Homeschooling to qualify:
- A pre-determined curriculum must be submitted for the upcoming academic period (monthly, quarterly, semester, or yearly) at time of initial application. The curriculum must be consistent with what would be expected in the classroom setting and must be age appropriate, a rough estimate of expected expenses (can be submitted monthly, quarterly, semester, or year), will be reviewed and approved by the Education Director to ensure likelihood of acceptability.
 - If utilizing an electronic platform for curriculum, the software must be pre-approved by the Education Director before purchase.
 - The applicant will be eligible to use up to \$1 500 of their homeschooling funding to purchase an age appropriate tablet/computer and/or printer to utilize with the approved software.
 - Requests for funding for services or supplies must be directly tied to a subject/topic inside of the approved curriculum and be reasonable and prudent in light of opportunities available to other Snoqualmie children, as may be determined by the Education Department.
 - Monthly educational box subscriptions will be approved if consistent with the provided curriculum and age appropriate for the student.
- Childcare of any kind is not an eligible expense

_____ I understand and agree that I am applying for this benefit as a matter of last resort, having exhausted all other funding opportunities available to me.

_____ FOR REIMBURSEMENT ONLY - I understand that I am required to turn in all original receipts and all receipts must:

- be readable and in good repair
- be clearly individually identified per student
- be dated between **July 1 and June 30** of the current Academic Year.
